#### *Three local organizations join to provide 24-hour phone access*

WARREN, Ohio (Nov. XX, 2006) – Coleman Behavioral Health has joined forces with Trumbull LifeLines and Community Solutions Association to provide 24-hour behavioral health services to residents of Trumbull County. Access to a trained professional is available to all residents by calling 330-393-1565 at any time.

LifeLines Access Center, which is located at Community Solutions Association on High Street in Warren, will now be staffed with behavioral health professionals from Coleman Behavioral Health to help with a wide range of behavioral health emergency or non-emergency situations.

Some of the services available through the new partnership are: access evaluation, assessment and planning for persons experiencing a behavioral health crisis; short-term case management to assist in receiving services from a provider of the customer's choice; and links for housing and employment assistance for persons with behavioral health challenges. Medicaid recipients are welcome, though not required, to use the new county-wide service. Residents should always call 911 first for urgent assistance by police, fire or ambulance services.
